MISSION AND PHILOSOPHY

CCIL was organized to serve as a leader in providing services necessary to ensure that persons with disabilities have the opportunity to achieve and maintain their highest level of independent functioning. Supporting this mission is the understanding that all individuals have the right to live as independently as possible and that the services needed to achieve and maintain independence should be available and accessible regardless of age, sex, race, ethnic background, religion, political persuasion, type of disability, financial status, or level of functioning.



The referral process can begin in person, by written request, or by a simple phone call to any of CCIL's seven offices. Individuals may refer themselves, other family members, or their friends. Any person having responsibility for or care of another individual may make a referral for service.

DD Services.....

Assist individuals in gaining access to needed social, educational, habilitation and medical services such as LPN, therapies, and in some cases, Personal Care services. DD services also include positive behavioral support in addition to case management and other types of assistance.

- CCIL professionals carry a small manageable case load which permits time for quality, personal service.

- CCIL professionals will make monthly visits to make sure you have all the services you need and that they are being provided in a quality manner.
- CCIL recognizes the **individual** through person centered planning rather than offering "one size fits all" services.



Developmental Disabilities



Service Coordination, sometimes called Case Management, is designed to help locate needed services and ensures personal strengths are identified and incorporated into person centered strategies. CCIL staff assists by linking individuals to desired and needed services and by monitoring the delivery of those services. These processes are used to assist in helping individuals to achieve their maximum potential and obtain their goals.

Habilitation Services are designed to meet training needs of individuals in their homes and communities. CCIL staff design training programs based on each individual's identified needs and assists with in-home staffing to ensure individuals obtain maximum independence. Additionally, this service allows for assistance with behavioral concerns by the development and implementation of positive behavior support plans developed by certified professionals.



To receive services, an individual must:

- Be at least 3 years of age
- Be Medicaid eligible
- Be diagnosed with an eligible diagnosis (Intellectual or Developmental Disability)
- Have assessment based identified needs
